6) STANDARD OF MEDICAL FITNESS:

The Candidates should be free from evidence of any contagious or infectious disease. The candidates should not be suffering from any disease which is likely to be aggravated by training or is likely to render him/her unfit for training or to endanger the health of the public. candidates should be free from evidence of tuberculosis in any form (active or healed).

Height, Weight, Chest Measurements and vision:

a) Height : 137 cms. b) Weight : 25.4 kgs.

c) Chest measurement : Expansion should not be less than 5 Cms

(irrespective of size of chest)

d) Vision : There should be no evidence of any morbid condition

of either eye or the lids of either eye which may be

liable to risk or aggravation or recurrence.

Selected candidates should satisfy the minimum standards of Physical Fitness as prescribed in the Apprentices Act/Rules and the standard prescribed for imparting training to the relevant trades should be certified by a Railway Doctor.

7. SOURCES OF ENGAGEMENT OF ACT APPRENTICES

The candidates who have registered with an employment exchange falling in the states of Tamil Nadu, Kerala & Union Territory of Puducherry alone are eligible to apply. However for SC/ST candidates and wards of serving/Retired/Deceased Railway employees such registration with employment exchange is not required.

8. APPLICATION

- a) Applications should be in the prescribed printed form only which can be downloaded from the website www.sr.indian railways.gov.in
- b) Application Forms will also be issued at the office of the Chief Workshop Manager from 23.05.2016 to 31.05.2016 between 10.00 AM to 12.30 PM and 02.00 PM to 17.00 PM (Except on Saturdays, Sundays and Closed Holidays) on production of NATIVITY CERTIFICATE/AADHAR CARD/RATION CARD/VOTER ID.
- c) A crossed Indian Postal order for Rs.100/- (Rupees Hundred only) drawn not earlier than the date of issue of this notification (Not Refundable) drawn in favour of the WORKSHOP PERSONNEL OFFICER, CARRIAGE AND WAGON WORKS, SOUTHERN RAILWAY, PERAMBUR, CHENNAI - 600 023 and payable at CHENNAI should be enclosed along with filled in application towards Processing Fee.
- d) SC/ST/PWD/Women Candidates are exempted from the payment of Processing Fee.
- e) Candidates should submit only one application irrespective of the number of trades/units applied for.
- f) Candidates should apply either for Fresher Category or Ex.ITI category not for both.

9. ENCLOSURES WITH APPLICATION FORM

The following attested copies should be enclosed along with the filled in application.

- a) Attested copy of certificate in support of Date of Birth
- Attested copy of VIII Std/X Std/XII Std Mark list in proof of Academic Qualification in case of Freshers
- c) Attested copies of certificates in proof of Academic and Technical Qualification (ITI certificate issued by SCVT/NCVT) in case of Ex.ITI. ITI Mark list should be enclosed.
- d) Since the selection is based on marks obtained in the Academic/Technical qualification, candidates must enclose attested copy of VIII Std/X Std/XII Std/ITI Mark list along with the application. Applications with out Mark lists will be summarily rejected.
- e) In the case of candidates belonging to SC/ST/OBC, Community certificate in the prescribed format issued by the competent authority, not below the rank of Tahsildar in the case of SC and RDO in the case of ST. OBC certificate should specifically indicate that the candidate does not belong to Creamy Layer.
- f) Disability certificate issued by competent authority in the case of Persons With disability (Physically Handicapped candidates).
- g) Proof for Employment Exchange Registration in the states of Tamil Nadu, Kerala and Union Territory of Puducherry. Attested copy of Employment Registration Card should be enclosed. SC/ST candidates and wards of Serving/Retired/Deceased Railway employees are exempted from submission of Employment Registration Card.
- h) The wards of Serving Railway employees should get certification from the immediate supervisor in the application form. In the case of wards of Retired/Deceased Railway employees, the attested copy of Service certificate should be enclosed.

10. SUBMISSION OF APPLICATIONS

- a) The filled in applications along with attested copies of certificates in a cover super scribed as "APPLICATION FOR ENGAGEMENT AS ACT APPRENTICE – COMBINED NOTIFICATION NO.1/2016/Act App/CW/PER' may be dropped in the separate box provided at the Personnel Branch of the office of the Chief Workshop Manager. But no acknowledgement will be issued.
- The filled in application along with enclosures in a cover super scribed as "APPLICATION FOR ENGAGEMENT AS ACT APPRENTICE COMBINED NOTIFICATION NO. 1 / 2016 / Act App / CW / PER " may also be sent to the WORKSHOP PERSONNEL OFFICER, OFFICE OF THE CHIEF WORKSHOP MANAGER, CARRIAGE AND WAGON WORKS, SOUTHERN RAILWAY, AYANAVARAM, CHENNAI-600023 by ordinary post.
- c) The filled in applications should reach this office by any of the two modes on or before 20.06.2016 by 17.00 Hrs. Applications received after this date will not be entertained. Railway Administration is not responsible for Postal Delay.

11. SELECTION

The selection will be on the basis of Merit List prepared in respect of all the eligible candidates who apply against the Notification. The Merit List will be prepared by the Committee nominated for this purpose by following the procedure mentioned as under:

- a) Fresher Category: Marks obtained in Matriculation (10th Std) will be converted for 200 and merit list will be drawn based on the converted marks duly ensuring Minimum 50% in aggregate marks in Matriculation.
- b) Ex.ITI: Marks obtained in Matriculation (10th Std)will be converted to 100 marks (duly ensuring Minimum 50% marks in aggregate) + ITI marks duly converted to 100. Total marks put together will be calculated for 200 marks and merit list will be drawn based on the converted marks giving equal weightage to both.
- For SC/ST, Ex.servicemen and PWD (PH quota) candidates the minimum percentage of 50% marks in aggregate in Matriculation is not insisted upon.
- d) In case of two candidates having the same marks, the older candidate will be preferred. In case the dates of birth are also same, then the candidate who has passed Matriculation Examination earlier will be considered.

12. OTHER CONDITIONS:

- a) The candidate should submit one application only for all the Trades/Units. He/She should apply either for Fresher or Ex.ITI category.
- b) Administration reserves the right to allot the selected candidate to any of the units. Units/Trades once allotted will be final and request for change will not be entertained.
- Academic/Technical qualifications acquired through recognized Boards/Institutes will only be considered.
- d) Diploma Holders/Engineering Graduates/Course Completed Act Apprentices will not be considered.
- e) Candidates applying for Ex.ITI category should possess ITI qualification in the relevant trade at the time of applying itself. The applications of the candidates without attested copy of SCVT/NCVT certificate in the relevant ITI trade will be rejected.
- f) Recent Passport size colour photograph should be affixed in the space provided in the application form and attested by a Gazetted officer. Photostat copy of Photo is not permitted. Administration may reject the application at any stage for pasting old/unclear photograph on the application or if there is any variation between the photograph pasted in the application and actual physical appearance of the candidate. Candidates are advised to keep sufficient copies of the same photograph ready for future purpose.
- g) Selected candidates should produce original Transfer Certificate for completion of qualifying examination at the time of verification of certificates. Transfer Certificate with higher qualification (Diploma/Engineering Degree) will not be considered.

- h) Candidates selected for training will not be allowed to withdraw from training except for reasons, which are beyond their control. Before commencement of training, the candidates should execute a contract of Apprenticeship.
- i) Those who willfully absent themselves are liable to refund the whole cost of their training as well as the amount paid as stipend as determined by the Central Apprenticeship Adviser. Also their Apprenticeship will be terminated as per extant rules under Apprentices Act 1961.
- j) The engagement and training are strictly in compliance with the provisions of Apprentices Act 1961 and there is <u>No guarantee for employment</u> to the Apprentices on successful completion of training.
- k) Every Apprentice on completion of the period of training and on passing a test (to be conducted by National Council for in Training in Vocational Trade to determine his proficiency in the Designated Trade) will be given a Certificate of Proficiency in the trade by the National Council.
- I) The selected candidates should abide by the rules and regulations framed by the Administration from time to time. If any information furnished by the candidate is found to be false, his/her candidature will be cancelled at any stage.
- m) The selected candidates will not be given any Hostel Accommodation (or any other facility). They will have to make their own arrangements for their stay during the training period.
- n) Such of those applications which are not complete in all respects and received without signature or without attested Photo or attested copy of certificate in proof of Date of Birth, Academic/Technical qualification/Community/Disability will be rejected.
- Applications without Indian Postal Order (Rs.100/-) towards Processing Fee will be summarily rejected without any intimation in this regard. However SC/ST/PH/Women candidates are exempted.
- p) Applications from the candidates who do not fulfill the conditions prescribed in this Notification will be summarily rejected without any intimation in this regard. No correspondence will be entertained in this matter.
- q) The decision of the Administration in regard to acceptance or otherwise of any application or in regard to selection of the candidates and their training even without assigning any reason will be final.
