Re-engagement for further periods may be issued in case of satisfactory performance after giving one day break on completion of the earlier period. However, engagement may be terminated from either side with one month's prior notice.
- 6. Incumbents to the abovementioned posts shall be entitled to annual enhancement in remuneration, leave, travel allowance and other benefits in pursuance of the approved HR Manual of TRLM.
